IMCA & Its Work

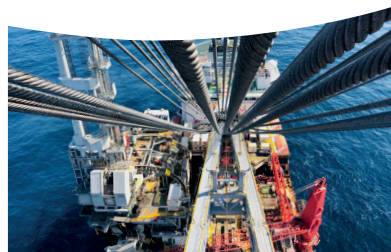
We are an international trade association. Our Members operate in the offshore construction industry around the world.
