**Our reputation** is of the highest standing. Our work, to which our Members contribute significantly, is well respected and sets high standards in the marine contracting industry.


## IMCA & Its Work

We focus on adding value for our Members by improving business performance. All our activities are carried out in strict adherence to our Competition Law Compliance Policy.

We have always been at the forefront of producing industry standards and guidelines for a wide variety of marine operations to improve safety and business performance. Initially these focused on diving and dynamic positioning (DP) in line with our heritage, however our focus has since expanded significantly into many segments of our industry. As a result, we have developed a well-respected library of industry leading documents which have become widely used and accepted.

IMCA guidance is used globally across the offshore industry.

Adoption of our guidance also includes:

- Reference by the International Maritime Organization (IMO)
- Regulatory acceptance of IMCA, by for example, the UK Health & Safety Executive (HSE)
- Reference to IMCA guidance by the International Association of Oil & Gas Producers (IOGP)
- Wide international recognition of the IMCA Diving Supervisor certification scheme

In addition to our strong technical drive, we are a communication platform for our Membership in promoting our industry with other organisations and regulators. In this respect we are highly engaged with the International Maritime Organization, oil company associations, and national regulators. We also provide a forum for our Members to meet and share professional ideas and opinions for the benefit of all.


Our global reach is organised into five geographic regions: Asia-Pacific, Europe & Africa, Middle East & India, North America, and South America.

The Secretariat provides the management and administrative support to the Association's business, including the document generation, review processes and publication. We leverage the knowledge and expertise of our Member companies, who are the best in the business.

## Governance

IMCA has a modern and effective governance structure and programme. We follow a strict code of practice and operate in conjunction with our Articles of Association, Bye-laws and Competition Law Compliance Policy.

#### **The Board**

We are governed by The Board of Directors of IMCA Holdings Ltd and, in keeping with tradition, the Chairman and Vice-Chairman of The Board are also given the honorary titles of President and Vice-President of the Association.

The Chief Executive is responsible for the day to day running of the Association and is accountable to The Board for overall performance of the Association and the Secretariat.

The Board provides strategic direction and leadership; monitors progress and ensures economic viability and legal compliance. The Board sets Membership criteria and monitors compliance in line with our Articles of Association and Bye-laws.

#### **Operations Committee**

**The Operations Committee** informs, helps to co-ordinate and leads the operations of IMCA by overseeing the programme of work and delivery plans of all committees.

It comprises the Chairmen of all our technical and regional committees. Its Chairman also serves on The Board.
